



Child Poverty Defined, 2019

- Poverty level
 - \$20,598 for a family of 3
 - \$25,926 for a family of 4
- 2018 Rhode Island Standard of Need
 - Single-parent family with 2 children would need \$55,115 a year to meet its basic needs, which would require a pre-tax income of \$62,844 to meet this budget without governmental subsidies.



Children in Poverty, by Race and Ethnicity, Rhode Island, 2014-2018





Homeless Children

- In 2019, 279 families with 603 children stayed in a homeless shelter or a domestic violence shelter in RI.
- During the 2018-2019 school year, Rhode Island public school personnel identified 1,475 children as homeless.
- Newport Public Schools personnel identified 82 children as homeless.






Children in Families Receiving Cash Assistance

Cash Assistance Caseload, Rhode Island, 1997-2019*





Starting in 2016, caseload data are for the month of December and not for a point in time, December 1.

- The Rhode Island cash assistance caseload has been steadily declining since the program began, but 230 children in 128 Newport families continued to benefit from this program as of December 2019.
- The goal of the RI Works program is to help very low-income families meet their basic needs by providing cash assistance and work supports, including employment services, SNAP benefits, health insurance, and subsidized child care.
- The maximum monthly benefit for a family of three is \$554 per month and has not been increased in almost 30 years.

- Of the 150,230 Rhode Islanders enrolled in SNAP in October 2019, 66% were adults and 34% were children.
- In Newport, 1,175 children received SNAP benefits as of October 2019.
- Receiving SNAP benefits decreases food insecurity and improves short and long-term health outcomes as well as high school graduation rates and adult earnings.










Effects of COVID-19 on Families with Children

Share of adult renters saying they are behind on last month's rent, as of week ending July 21



Note: Behind on rent or mortgage = did not pay on time or deferred payment. Didn't get enough to eat = household had "not enough to eat" sometimes or often in the last 7 days. Other or multiracial, not Latino = people identifying as American Indian, Alaska Native, Native Hawaiian, or Pacific Islander, or more than one race. Chart excludes those who did not respond to one or both hardship questions. Listed household races/ethnicities are based on that of the adult responding to survey. Survey does not collect data on children directly; figures for children are estimated based on number of children in each household. For children in households that neither have a mortgage nor pay cash rent, such as those living in employer-provided housing, hardship is determined based only on whether these households had enough to eat.



In 2019, 218 babies were born in Newport.


- 11 Newport babies were born to teen mothers.
- 25 Newport babies were born to mothers without a high school diploma.
- 98 Newport babies were born to single mothers.
- 96 Newport babies were born to low-income mothers.






Children with Lead Poisoning



- Asthma is one of the most common chronic conditions among children and a leading cause of school absenteeism.
- Newport's rate of asthma-related emergency department visits was 9.5 per 1,000 children, among the highest in the state with only the rates for Central Falls, Providence, and Woonsocket higher.




Prevalence of Overweight and Obesity in Rhode Island Children Ages 2 to 17, 2018

Children's Mental Health



• In Rhode Island:

- 19% of children ages 6-17 has a diagnosable mental health problem and 10% have a significant functional impairment.
- > 36% of children ages 3-17 who needed mental health treatment or counseling had trouble getting needed care.
- In 2019, 15% of Rhode Island high school students reported attempting suicide in the past year.
- ▶ 6,639 children under age 18 were treated at a CMHO in 2019.
- > 2,865 emergency department visits by children under age 18 for a mental disorder in 2018.
- > 1,864 hospitalizations by children under age 18 for a mental disorder in 2018.








Youth Referred to Family Court


**Other includes offenses such as conspiracy, crank/obscene phone calls, computer crimes, and possession of a manipulative device for automobiles, etc. Probation violations, contempt of court, and other violations of court orders are not included in the offenses above.

Of the 4,630 wayward and delinquent offenses for which youth were referred to Family Court in 2019, 5% were for violent crimes.


- 75% decline in youth in the care and custody of the Training School from 2008 to 2019 after a cap was placed on the population in July 2008.

Newport's reported child neglect and abuse victim rate was 26.5 victims per 1,000 children in 2019, the **third highest in the state**.







Child Care Subsidies, Rhode Island, 2001-2019





- In December 2019, there were 10,580 child care subsidies in Rhode Island, up 2% from December 2018, but down 26% from the 2003 peak.
- **247 Newport children** from ages birth to 12 receive a subsidy for child care.

- The only licensed family child care home in Newport does not participate in BrightStars.
- 1 public school with a preschool program participates in BrightStars.
 - It does not have a high-quality rating of 4 of 5 stars


34% of all children and 39% of low-income children in Newport were enrolled in either Head Start or RI Pre-K during the year before kindergarten.

Multilingual Learners/English Learners in Newport and Rhode Island, 2015-2019







Eighth-Graders Meeting Expectations in Math, 2019





In **Newport**, **22% of K-3 students missed 18+ days of school** during the 2018-2019 school year, higher than the state rate of 14% and up from 16% in 2017-2018.



Chronic Absence, Middle School and High School

- Newport's chronic absence rate in middle school was 13% during the 2018-2019 school year, lower than the state rate of 17%.
- The high school chronic absence rate was 42%, the third highest rate in the state.



- Newport's suspension rate has declined from 24 suspensions per 100 students in 2013-2014 to 15 suspensions per 100 students in 2018-2019 and is now the same as the statewide rate.
- During the 2018-2019 school year, 100% of Newport's suspensions were out-of-school suspensions, compared to 46% in the state as a whole.



High School Graduation Rate, 2014-2019



Of the 169 Newport students who entered 9th grade in the 2015-2016 school year and were expected to graduate in 2019, **78% graduated in 4 years**, 17% dropped out, 1% obtained a GED, and 5% were still in school.



Immediate College Enrollment by Family Income, Race, Ethnicity, and Type of College, Class of 2018, Rhode Island


